


## **New GST Returns**

• New GST returns, i.e. Normal, Sahaj and Sugam, will effective from **01st April**, **2020**.


### Which returns to Opt

- GST Ret-1 is a monthly return mandatory for turnover exceeding 5 crores, for others it can be filed quarterly. Credit can be claimed for invoices not reflected on the portal
- GST Ret-2 (Sahaj) and GST Ret-3 (Sugam) are quarterly return
